1. Privacy Policy

This Privacy Policy explains how MasjidConnect.cloud ("we," "us," or "our") collects, uses, shares, and protects personal information gathered from users ("you" or "your") of our website and services. 1.1. Information We Collect

- For Business Transfers: In the event of a merger, acquisition, or sale of all or a portion of our assets, your information may be transferred to the acquiring entity.
- **For Legal Reasons:** We may disclose your information if required to do so by law or in response to valid requests by public authorities.
- **To Protect Our Rights:** We may disclose your information where we believe it is necessary to investigate, prevent, or take action regarding potential violations of our policies, suspected fraud, or situations involving threats to the safety of any person.
- Aggregated or Anonymised Data: We may share aggregated or anonymised data that cannot reasonably be used to identify you with third parties for various purposes, including analytics, research, or marketing.

1.5. Your Data Protection Rights
